

INTRODUCTION

Orphanage and a boarding school for under privilege children especially girl child strives to provide underprivileged children girls in Rural Pune and Aurangabad, with quality education that will help them to break the cycle of poverty.


The project goal is to generate sufficient income through focusing on horticulture, poultry, dairy cows, and renewable energy systems so as to meet educational, nutritional and medical supports needs of the children we support.

This project aims to support at least 200 orphans and vulnerable children and specially girls between 3 and 14 years by the year 2020.

The primary target groups are children and specially girls from the lowest income populations, particularly those who are affected by the prevalence of HIV/AIDS in various in and around Pune and Aurangabad. We will enroll 5 free paying students in every class to enable parents who are not able to pay fees to participate in the education of needy girls.

The strategy we have adopted to provide quality education to these children is through the establishment of a boarding school known as **RADHEYA FOUNDATION TRUST** which will provide holistic education that addresses both the physical and emotional needs of the children while creating dignity through self-reliance.



Formation of student recruitment / admissions committee (teachers, parents representatives and Admins)

Linkages will be developed with local government/community administration (assistant chief, community elders and church leaders) to help identify and refer bright and needy and orphan students to the school

The girls at **RADHEYA FOUNDATION TRUST** will be provided with free education at a nominal fee for 3 years. Three free meal a day will be provided

Caretakers and matrons will be employed at the school and orphanage to look after the girls.

Monitoring of individual child performance.


The matrons will monitor the progress of the individual student in the boarding house.

PRESENT PLANS AND NEEDS

The school plans to get materials, financials support and in kind donations to help meet its objectives from individuals, companies, religious organizations, the business fraternity, friends , external donors, the government and other organizations.

RADHEYA FOUNDATION TRUST's immediate needs are mainly in making the new boarding school ready for the children by **December 25th 2020** and these include:

- a) Plastering the walls/floors, making ceiling, putting up glasses on doors/windows and painting the first 4 classrooms.
- b) Construction of a boarding house to accommodate 100 children by 31st August 2020.
- c) Digging wells / bore wells to provide running water at the school and for sale to the community to generate income for the school by August 2018.
- d) Construction of Kitchen, Toilets , Shower room, and fencing the compound
